Dear Sir/Madam,

We have received a complaint of ragging from a student of **Acharya Brojendra Nath Seal College**. You are requested to identify & counsel the victim so that he feels safe and knows that authorities are with him & action will be taken on him complaint. You are also requested not to disclose the identity of the victim. The details are given below.

"7.1 action to be taken by the head of the institution by the order of hon. Supreme court:
On receipt of any information concerning ... Any reported incident of ragging, the head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a first information report (fr), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely:
V. Violation of decency and morals through ragging;
VI. Injury to body, causing hurt or grievous hurt;
X. Assault as well as sexual offences or unnatural offences;
XI. Extortion;
XII. Physical or psychological humiliation;
Note: Enquiry/Investigation /disciplinary committee reports etc. Are not acceptable. As per ugc regulations only report of the anti ragging committee is acceptable.

The Anti-Ragging Committee of Acharya Brojendra Nath Seal College, Cooch Behar, West Bengal has carried out its investigation against the Complaint No.: WB/04-2022/91 on 18. 04. 2022 at 12.15 P. M.

In presence of Hon'ble Principal of the College, the Committee has met the Superintendent of the Nripendra Narayan Boys' Hostel via Google Meet (Meeting Link: <https://meet.google.com/yfp-vtk-iyb>) from whom the Committee came to know that the "victim" started residing as a boarder in the said hostel on and from 20. 03. 2022.

The members of the Committee also met all UG and PG boarders (in individuals and in groups) of the hostel in several times on 18. 04. 2022 and 19. 04. 2022.

(i) Details of investigation done by Anti-Ragging Committee Members:

1. Although, as per instruction from your end, the details of the "victim" are not being disclosed here but, according to your request the Committee has identified the "victim" named Washim Akram, an M. A. Second Semester (First Year) student and a boarder of Room No.: 26 (PG Block).
2. After thorough investigation, the Committee found that it is not a case of ragging in any form or any shape. On a matter of discussion, the boarders pursuing UG and PG degrees including Koutak Barman (Not Koutuk Roy) who himself is the Prefect and Prakash Barman got involved in arguments and counter arguments with the "victim". This resulted some misunderstanding among them.
3. The Committee found that due to some personal issues, the "victim" left the hostel on 10. 04. 2022 and has come back in his room on 19. 04. 2022 along with his elder brother named Firoz Hossain who launched a complaint in favour of his younger brother/ "victim" without knowing the entire matter from his brother. Now, after hearing all the matters, Firoz Hossain expressed his satisfaction and wished to withdraw his complaint in written form whose copy is enclosed herewith.
4. The "victim" will be availing his hostel room on and from 20. 04. 2022 after making his belongings available in his allotted room.

(ii) Conclusions of the investigations:

The Committee also found in its independent investigation that no such unnatural offences like physical and mental harassments, assaults, late night introductions do occur in any room/place of the hostel.
