

#### 3. Response Summary:

The feedback collected from employers on the curriculum and infrastructure of Acharya Brojendra Nath Seal College for the 2023-2024 session is summarized below:

- a. Employability of Syllabus: 25% of respondents rated it as Excellent, 58.33% rated it as Good, and 16.67% rated it as Satisfactory. There were no Average or Not Satisfactory ratings.
- b. Scope for Skill Development: 16.67% rated it as Excellent, 66.67% rated it as Good, and 16.67% rated it as Satisfactory. No respondents rated it as Average or Not Satisfactory.
- c. Balance between Theory and Application: 33.33% rated it as Excellent, 50% rated it as Good, and 16.67% rated it as Satisfactory. No respondents rated it as Average or Not Satisfactory.
- d. Scope for Higher Education/Employment: 16.67% rated it as Excellent, 58.33% rated it as Good, and 25% rated it as Satisfactory. There were no Average or Not Satisfactory ratings.
- e. Awareness of Recent Developments in Job Market: 58.33% rated it as Excellent, and 41.67% rated it as Good. There were no Satisfactory, Average, or Not Satisfactory ratings.
- f. Infrastructural Advantages: 25% rated it as Excellent, 66.67% rated it as Good, and 8.33% rated it as Satisfactory. No respondents rated it as Average or Not Satisfactory.
- g. Resourcefulness of the College Library: 60% rated it as Excellent, and 40% rated it as Good. There were no Satisfactory, Average, or Not Satisfactory ratings.
- h. Overall College Ambience: 66.67% rated it as Excellent, 16.67% rated it as Good, and 16.67% rated it as Satisfactory. There were no Average or Not Satisfactory ratings.
